



**East Sussex Assembly Conference 2011
3 November 2011, Winter Garden, Eastbourne**

CONFERENCE REPORT – January 2012

BACKGROUND:

The East Sussex Assembly meets once a year to receive a report on the East Sussex Strategic Partnership's (ESSP) activities and achievements during the previous year and to be involved in identifying and agreeing future priorities that ESSP and wider partners should focus on. Over 40 delegates attended from partner organisations across the public, private, community and voluntary sectors.

The Assembly 2011 was about 1) updating Assembly members on the progress of the priorities identified at the Assembly in 2010; 2) providing The Picture in East Sussex (with a focus on national context and ESSP achievements since the Sustainable Communities Strategy was developed, and what we can expect for the future of East Sussex); 3) highlighting progress and challenges of the Pride of Place Themes with a roundtable discussion on areas for future focus; and 4) a seminar on funding to share information on planning, writing and presenting successful partnership bids for external funding.

ASSEMBLY ITEMS:

1) Priorities

Speakers provided progress updates on the three priority areas identified at the Assembly 2010 as key issues that would benefit from focus from the ESSP. Further updates on these activities will be provided at the ESSP meeting in January 2011.

Families with Multiple Problems

Alison Jeffery (East Sussex County Council) provided the update. The working group aims to support families with multiple problems more effectively, with the priority to aim for better outcomes for these families, with another potential outcome being lower costs to the community as a whole.

Since July 2011, discussions with partners have taken place which led to the establishment of the project. Alison highlighted the complexities of the project, and the importance of understanding what is and what is not working in East Sussex, and getting support from a range of services. In-depth research was carried out during the autumn. Discussion will

follow to build consensus around a new approach to families with multiple problems which will be piloted from April 2012.

Communications and Engagement

Bethan Hampson (East Sussex County Council) provided the update. The ESSP website re-launch and a questionnaire on ESSP communications have been key areas of progress.

The new website is laid out around the themes to make it easy to navigate. It has helped to streamline the administration of communications, and has provided opportunities for increased engagement, for example in relation to NHS Reforms activity.

The ESSP communications questionnaire was completed by over 80 partners from the ESSP, the Assembly and those who receive information and Newsletters. The feedback gained has guided work on two key projects:

- A method allowing users to subscribe to receiving the type of information that they are interested in, and the frequency of receiving it; and
- A members' only forum to allow for discussion/ circulation of items outside of meetings.

Strategic Property Asset Collaboration in East Sussex (SPACES)

Robin Smith (Chair of ESSP, Sussex Police) provided the update. The SPACES group is made up of organisations from across the public and voluntary and community sectors, many of which are Assembly members. So far, value of property ownership across the eight organisations exceeds £960m with lease and other running costs totalling £56.35m a year.

SPACES has been included in the Department for Communities and Local Government's Capital and Asset Pathfinder Programme, and a member of SPACES met with Baroness Hanham, Parliamentary Under Secretary of State for Communities and Local Government in October 2011. The Government sees this approach as a key tool to drive savings and service improvement. Partners have worked to identify a direction of travel and early opportunities with the aim to submit business cases by December 2011 and a strategic plan by March 2012. Robin highlighted the need for commitment 'at the top' from all partner organisations to drive down the total size and cost of the public estate in East Sussex.

2) The Picture in East Sussex

Robin Smith and Becky Shaw (East Sussex County Council) presented on The Picture in East Sussex. Using an interactive activity, they encouraged the Assembly to look back to when the Sustainable Community Strategy was developed (2008) and think about how the national and local context has changed. Key ESSP achievements spanning from 2008-2011 were highlighted. Robin and Becky then asked the Assembly to think about emerging issues and what they do and don't know about the future for East Sussex. They highlighted that although there will be challenges, the past achievements demonstrate the resilience of the Assembly organisations and the role that collaboration will continue to play in East Sussex.

3) Update on Pride of Place: Round table discussion

In a Round Table discussion format, the Assembly were asked to look at progress reported on a Pride of Place Theme(s). The groups were asked:

- Do you think that the actions are still relevant, and do you agree with proposed amendments?
- Can you recognise that progress has been made?
- Are there any additional areas for action/ focus?

The tables attached as Appendix 1 summarise the discussion around each theme, highlight the suggested areas for future focus and show any proposed changes to key tasks and actions in Pride of Place.

4) How to be successful when applying for funding in partnership

Véronique Poutrel (East Sussex County Council) presented a seminar on applying for funding, outlining the services of the External Funding Team. This followed a request at the ESSP meeting in July 2011 for advice on funding, in particular bidding in partnership. The presentation covered advice on writing successful application, evidencing need and how to bid jointly for success.

As an outcome of this seminar, the External Funding team have been in discussion with a number of Assembly member organisations to work on bidding.

FEEDBACK:

All delegates were provided with an event feedback form. The following results are based on the 14 forms returned. The results are set out in graphs as Appendix 2. The main points are:

- The majority of respondents felt that the event met expectations; the Assembly content was appropriate; timing and duration was appropriate; and pre event admin was sufficient.
- The item that most respondents found the most useful was the Update on Pride of Place round table discussion, followed by: the Priorities updates (the SPACES presentation highlighted as particularly useful); The Picture in East Sussex presentation; Networking; and the Funding seminar.
- The ideas suggested for next year's Assembly (set out in Appendix 2) include: more focus on the three Priorities; and focus on various reforms that will impact on the way Assembly organisations will work.

What we have learned:

- The majority of feedback was positive which indicates that the issues presented were of interest and appropriate. We will aim to continue this in 2012 by taking on board suggestions of topics for next year's Assembly.
- One group lacked clarity on the Round Table discussion and felt they didn't have enough handout information provided to make the most of the exercise. This will be avoided in the future by ensuring that all resources/ hand outs are clear and comprehensive and that exercises are facilitated.
- The respondents who selected the Funding seminar as least useful commented that they found it interesting; but they felt that as strategic members, they were not the

appropriate audience. In the future, pre event admin will go further to highlight where particular items may be more focused, and encourage the invitation of additional delegates where relevant.

RECOMMENDATIONS:





The ESSP is recommended to:






1. Note the presentations and progress reported to the Assembly;
2. Note the feedback and suggestions for next year's Assembly; and
3. Agree actions and areas of future focus for the Pride of Place themes (set out in Appendix 1), resulting from the Round Table discussion exercise.
