	Definition: The Prolific and Other Priority Offenders Strategy seeks to reduce adult re-offending rates of Priority and Prolific Offenders PPOs. Targeting those offenders who have a proportionally large impact on local crime rates, will result in a measurably significant reduction in our rates and consequent reduction in fear of crime. In the case of adult offenders there are two identifiable strands or groups of offenders who are targeted for interventions, these are 'Catch and Convict'- actively tackling those who are already prolific offenders, 'Rehabilitate and Resettle' working with identified prolific offenders by offering a range of supportive interventions, these offenders will be offered the opportunity of rehabilitation or face a swift return to court.

<b>Resources:</b>	<b>Sussex Probation Area provide dedicated staff to work with this offender group: 2 Full time Probation Officers and 1 full time administrator. Sussex Police contribute 2 full time Police Officers co located in Hastings and Eastbourne with probation colleagues. Hastings and Rother CDRP contribute to the funding of 1 full time Probation Service Officer in Hastings. Currently there is no financial support provided to these schemes from Eastbourne, Lewes and Wealden CDRPs. In previous years there has been funding for a Probation Service Officer in Eastbourne. It is planned that the `reward ` monies gained by the scheme as a result of excellent performance through 2007-8 be re-invested into the scheme through 20010-12 . A PPO co-ordinator is responsible for all administration attached to the management of the scheme and this post is funded by Sussex Police.</b>
